GENERAL INFORMATION

SUPERLOCK™ adjuvant is a high surfactant oil concentrate (HSOC) with a built-in oil emulsion drift and deposition aid that is designed to improve pesticide performance including herbicides like glufosinate, 2,4-D, mesotrione, clethodim and others. The surfactant system in SUPERLOCK™ is NPE-free.

RATES OF APPLICATION

For optimal performance, apply SUPERLOCK™ at a rate of least 12 fl. oz/A. SUPERLOCK™ may be used at rates that are less than or equal to the rates recommended on pesticide labels. See table below to determine the appropriate rate of SUPERLOCK™ compared to conventional oil systems recommended on pesticide labels.
