#### GENERAL INFORMATION

VALCHECK II is a non-AMS water-conditioning agent with surfactant and drift reduction agent with defoamer, that is formulated to enhance glyphosate performance in dicamba tank mixtures.

#### DIRECTIONS FOR USE

VALCHECK II may be used as a drift reduction agent (DRA) according to the table below. Tank mix combinations must show that VALCHECK II is approved as a DRA before use. This information is available on the respective herbicide tank mix website.

#### MIXING

All spray mixing and application equipment must be thoroughly cleaned before pesticides are applied.

1. Fill spray tank half full of water and start agitation.
2. Add desired rate of VALCHECK II to water before adding pesticides.
3. Add pesticides as directed by the label, while maintaining agitation.
