**GENERAL INFORMATION**

AMSURF XTRA is a multi-functioning liquid ammonium sulfate based water conditioner, surfactant, and drift reduction agent. AMSURF XTRA is designed to improve the performance of herbicides by reducing antagonism in the spray tank and improving coverage. AMSURF XTRA reduces fine droplets that result in spray drift\* while increasing spray deposition for improved uptake by the targeted weed species.

AMSURF XTRA at 2.5 gallons per 100 gallons:

- Delivers 8.5 lbs of ammonium sulfate
- Delivers 1 qt of surfactant blend
- Delivers a optimized rate of a drift reduction agent/deposition aid

\*Spray drift reduction is dependent on many factors including equipment setup and weather conditions. **MIXING INSTRUCTIONS**  
**SHAKE WELL OR RECIRCULATE BEFORE USE.**

1. Fill sprayer 1/3 to 1/2 full of water
2. Add dry flowables or dispersible granules
3. Add emulsifiable concentrates
4. Continue to agitate until tank is 3/4 full
5. Add AMSURF XTRA last to the agitating spray tank

**RECOMMENDED RATES**

- Standard: 2.5 gallons per 100 gallons
- 1.25 to 5 gallons per 100 gallons\*

\* Note: Inclusion below 2.5 gallons per 100 gallons may not offer optimum performance and rates above 2.5 gallons per 100 gallons may not be acceptable to all spray tips and pressures.

**STORAGE AND DISPOSAL**

**Storage:** Store product in the original package only. Store in a clean, dry facility away from oxidizing agents.
